3. Apart from temporal exchanges of Resource Persons we may send the students for interaction on spot for handsome experience.
4. For these purposes seminars/ symposia may be conducted with due consent and participation of two parties.
5. Such MOU will be dealt with normal and routine training programme. Any intricate and different type of activities will require other types of agreement.
6. In case of the use of name, fame, logo and other achievements written approval is a pre-requisite.
7. MOU will be valid for 5 years from the date of agreement. Renewal may be permitted with provision of modifications if needed. In this context mutual written consent will be needed from both sides.
8. MOU may be terminated with prior notification from either parties amongst the two in writing not later than 6 months before the date of termination.
9. As we belong to the category of Higher-Education Institutions and you in the category of Secondary/Higher Secondary Educational institutions we may provide you better supplements as we are agreed upon.
10. Both school will encourage to take admission their sportsperson to Dr. Bhupendra Nath Dutta Smriti Mahavidyalaya in future and college will provide requisite facilities.
11. MOU may go through amendments with due consent from both sides.
