### Article 1

#### OBJECTIVE OF COOPERATION

## Article 2

## Article 3

### LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article 2 at Rishi Bankim Chandra College and Dr. Bhupendra Nath Dutta Smriti Mahavidyalaya
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

## Article 4

### MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted primarily in the Offline mode. Ample arrangements should also be made to conduct programmes in the online mode, if required.

## Article 5

### DURATION AND TERMINATION

- 1) This LINKAGE shall enter into force on the date of signing.
