**ACTION TAKEN REPORT ON FEEDBACK ON CURRICULUM:**

On the basis of analysis of feedback on curriculum from teachers and alumni the following recommendations are made by the IQAC and communicated to the Governing Body for their onward action:

The majority of **teachers** have a favourable opinion regarding the syllabus. The syllabus is well defined, need based, flexible addressing cross cutting issues like gender, ethics, human values, environment and sustainability. However, the faculty is of the opinion that the syllabus needs to be updated at regular interval. And the issue of balance between the theoretical and practical learning experiences needs to be increased.

Alumni feedback have opined to make the curriculum industry friendly to increase the accommodation of the outgoing students in the job market.
